**Online Database of Ingredients (ODI)** – This new tool provides focused search results for a single ingredient or an entire ingredient statement. Results are displayed with links to the complete definition text in the online OP or the electronic Code of Federal Regulations (CFR). Subscribers can populate their unique User List with common or usual ingredients. The ODI tool is only available with an Online OP subscription. A training video is being developed and training webinars may be available if needed.
