- 1.) Nancy Thiex, Mark Budden (FASS) and Andy Crawford have taken over the collaborative check sample duties of Dr. Victoria Siegel. Many duties that Vicki performed have been taken over by FASS.
- 2.) Mark Budden presented a Report and Upgrade proposal to the check sample program website.

3.) Other changes

5.) Drugs - Nancy

- Hard to obtain many of the drugs
- Dale Hill will make a lab sample at their pilot plant.
- Need to decide what drugs will be added to the lab sample. The mix will need to be carefully selected since some of the drugs may be in an "illegal" combination. Dale asked that AAFCO provide him a letter for their files explaining the program and the sample. Several members expressed concern that FDA inspectors could have issues with this "lab" sample Nancy contact Eric Nelson.
- There was a suggestion from the floor to only add the drugs to the current check sample program.
- At least 12 labs represented at this meeting indicated that they analyze for drugs.

Action Item: Dale will pull together a proposal on costs. The proposal will be sent to the committee. The committee will use e-vote to approve or not approve the proposal.

Action Item: Nancy will send out a survey to find out what drugs labs are currently seeing in samples.

6.) ISO 17043 update – Nancy

No progress since August 2013, foresees little progress in the next 6 months. Nancy requested monies for a consultant to assist with accreditation. She was given approval by the board to proceed with obtaining proposals.

7.) Chair and Vice Chair

The roles of these two positions need to be defined for ISO 17043.

A quality oversight team had been formed earlier in the process and has met once (Sharon Webb). Not sure what happened to the information.

8.) Materials for 2015

Contact Nancy of you have material available for the program to use. She's looking for diversity. Dale volunteered to help Nancy.

The first sample for this year is dried brewer's yeast.

Other suggestions:

- Pork meat and bone meal
- Chicken-by-products
- Chicken meal
- Pork and chicken combo
- Brown rice
- Whole flax seed (high oil). Include special instruction on preparing these samples for an analysis.
- NPN At higher level Urea and another nitrogen sources

Nancy will update method codes. It was noted that there are a few missing.

Action Item – add method codes including % Fatty acids. Nancy will work with Gina.
