1. Welcome & Introduction

Vice Chair – Dave Phillips called meeting to order and conducted meeting. Thanked everyone for attending and for all their time spent on the committee.

2. Dairy Cattle Nutrition Panel Update

Dave Dzanis indicated the Dairy NRC started its review in September, 2014. and further elaborated that it may be 2-3 years before being published. He said we could start looking at it now and beef as well.

Jan Campbell – Commented that we historically review guarantee specie by specie.

Miriam Johnson – Suggested putting dairy on hold and move on to beef review since the Beef Cattle NRC release is expected to be around March, 2015.

Audience Comment – Richard Sellers (AFIA) Very expensive for industry to make changes and to give industry time to review. Richard offered to supply list of experts to potentially serve on beef panel.

Request for a volunteer to head up the Dairy Cattle Nutrition Panel was made. (After the meeting Alan Harrison KY volunteered to head the panel)

General consensus was to start working on Beef next.

3. Swine Nutrition Panel Update

Presentation of Zinc Changes

Miriam Johnson & Expert panel consisting of academia and industry report recommended removing Zinc Guarantee.

the Non-Pet Food Labeling Guide in order to keep it current.

5. Feed Labeling Training Module for Inspectors

Meagan Davis offered that several states offer this training for their inspectors and suggested pulling this information from them to combine into one feed labeling training module and she would like to lead this.

Mike Davidson Indicated he was already working on this with the FDA Outreach and Education Workgroup and labeling would be a part of this. Indicated this would be a duplication of effort.

Consensus was for Feed Labeling to not take this on.

b/ Sodium guarantee required only when total sodium exceeds that furnished by the maximum salt guarantee.
